Conditions of Entry – Professional Cricket Matches

By attending a professional cricket match at Saxton Oval and Pavilion, you agree to abide by the following terms and conditions. These rules are designed to ensure safety, comfort, and enjoyment of all spectators and participants.

Smoking and Vaping

This venue is a smoke-free and vape-free environment. Patrons must leave the fenced area of the venue to smoke or vape. Re-entry passes will be issued if necessary.

What can I bring into the venue?

- Sealed, unopened plastic bottles (up to 1.5 litres) containing non-alcoholic beverages.
- Empty plastic bottles (up to 1.5 litres) to be filled using water provided within the venue.
- Soft-sided bags, such as chilly bags, up to 350mm x 300mm x 400mm in size.
- Deck chairs – these can only be used at the top of the embankments to avoid restricting the view of other patrons.
- Small, collapsible umbrellas (smaller than a golf umbrella) as long as they don't restrict the view of other patrons.
- Small amounts of food for personal consumption. Commercially packaged fast food (e.g. takeaway meals) are not permitted.

What am I not allowed to bring into the stadium?

All spectators and their belongings may be subject to searches upon entry, during events, or when exiting the stadium. Prohibited items will be confiscated, and individuals in possession of such items may face removal from the venue. The following items are prohibited:

- Alcohol that has not been purchased at the venue.
- Illicit drugs.
- Glassware, thermos flasks and any breakable containers.
- Cans, unless they are depressurised (opened) by security upon entry.
- Unsealed bottles and containers.
- Drink containers larger than 1.5 litres.
- Hard-sided chilly bins.
- Beach trolleys.
- Hi-vis clothing of any description.
- Sound amplifiers, including loudhailers, whistles and airhorns.

- Animals (except certified assistance dogs).
- Flares, fireworks and laser pointers.
- Knives, firearms, or any other items that could be considered dangerous (note: butter knives are considered knives and will be confiscated).
- Skateboards, rollerblades, scooters (unless used for mobility purposes) or bicycles.
- Obscene, offensive, abusive or oversized signs or banners. This is at the sole discretion of the Event Management Staff. In all cases flag poles must be limited in length to no more than one hand width longer than the flag/banner.
- Musical instruments, unless pre-registered with Event Management Staff.
- Cameras, video or audio recording equipment for any purpose other than private non-commercial use. The Event Management Staff will at their sole discretion determine whether or not an item is intended for personal or commercial use.
- Clothing that contains gang patches.

Venue Entry

All patrons and their possessions may be subject to a search prior to being granted entry into the venue.

Any authorised vehicles entering/leaving the venue may be subject to a search.

Patrons may be refused entry or evicted from the venue if they:

- Do not have a valid entry ticket or accreditation pass.
- Appear intoxicated or under the influence of drugs.
- Fail to comply with staff or security requests, including searches.
- Are in possession of prohibited items.
- Are verbally abusive, or behave offensively.
- Throw any objects or projectiles.
- Have been previously evicted or served with a trespass notice.

- Enter or attempt to enter the playing area before, during or after the event.
- Enter restricted areas without appropriate accreditation.
- Attempt ambush marketing.
- Engage in any form of betting or gambling (including by third parties) at or around the venue (in addition to eviction, further sanctions and penalties may apply).
- Commit any act deemed a crime under New Zealand law.

Any eviction from the venue may, at the sole discretion of Venue Management, result in a trespass notice being issued, which will prevent the patron from attending events at the venue for a period of up to 2 years.

General

- All patrons enter the venue at their own risk.
- Unauthorised selling of merchandise, advertising or promotional giveaways is prohibited.
- Alcohol will not be served to minors or intoxicated persons.
- No patron may remove alcohol from the fenced area of the venue.

Evictions

Failure to comply with a direction from Event Management Staff or NZ Police to leave the venue may render the patron liable to arrest and prosecution for the offence of trespass under section 4 of the Trespass Act 1980, as amended, which is punishable on conviction by a fine not exceeding \$1,000 or a term of imprisonment not exceeding 3 months in terms of section 11(A) of the Trespass Act 1980, as amended.

Conditions Acceptance

By purchasing, possessing, or using a ticket, you agree to these terms and conditions. If you purchase a ticket for someone else, you confirm that you have the authority to accept these terms on their behalf.
